Some of our top industry hot button issues right now are related to Government policy

and/or intervention. Here are a few of our top concerns:

1) The boatyard permit issue. Ongoing issues with Puget Soundkeeper Alliance and their sponsored lawsuits under the federal Clean Water Act., our own state Dept of Ecology.

2) The battle for state revenue previously marked for and spent on boating projects and programs, but which has been striped in the current budget

crisis. This is over \$2,000,000 in funding.

3) Threats of new taxes or tax law changes that would negatively affect our businesses.

4) NOAA related issue to protect Orca whales. Proposed boating "no-go zone" on the west side of San Juan Island, in a 6.2-square mile area stretching from Mitchell Bay down to Eagle Point. We are questioning the science and impact.

It is critical that we continue to have a strong voice in Olympia and in politics. It is equally important that we support our members as governmental regulation and/or bureaucracy affects their businesses individually.

In a more general sense, and as related to issues that arise at the board level, I basically try to work on behalf of our entire membership and take actions that would best suite all of our businesses as well as the association's own good health.
